National Strategy on ESD 2014 - 2020

"Aims to ensure that education contributes to sustainable development by equipping learners with the relevant knowledge, key dispositions and skills and the values that will motivate and empower them throughout their lives to become active informed citizens who take action for a sustainable future".

Policy areas include:

- natural resource management, urban decay, water security).
- patterns, corporate responsibility, population growth, migration).

- Environmental (Climate change, disaster risk reduction, biodiversity, environmental protection,

Socio-economic (economic growth, poverty, food prices, child labour, social exclusion, justice, debtsecurity, human rights, health, gender equality, cultural diversity, production and consumption

Political (Citizenship, peace, ethics, human rights, democracy and governance).

ESD for 2030

Culture Pillar?

Culture, including language and communication aspects, are crucial to sustainable development as the effectiveness of how people interact dictates how societies and economies improve or 'progress' and **how people can work together to protect and conserve our planet**. For this reason, Target 4.7 addresses the appreciation of cultural diversity and of culture's contribution to sustainable development as being core to the knowledge and skills necessary to promote sustainable development.

Through engagement in ESD, learners develop the knowledge and skills that allow them to appreciate and respect how **diverse values**, **beliefs**, **languages**, **art**, **music**, **skills and traditions contribute to the communities and culture in which they live** as their own sense of identity develops and evolves. Learners recognise that cultural diversity is vital in ensuring the sustainability of their communities. **Cultural identity** and a sense of belonging are essential for the sustainability of individual and collective wellbeing, reflecting the **interdependence between culture**, **sustainable development and citizenship**.
