	<p>Dr Vivienne Patterson, Head of Skills, Engagement & Statistics, HEA</p> <p><i>Vivienne has a degree in Zoology from UCC and a master's in biotechnology and Doctorate of Science from DCU. In 2006 she joined the team at the Higher Education Authority as Head of Statistics where she led the Statistics Unit for 10 years. During that time Vivienne was responsible for transforming the communication of education data publishing a number of key reports. Since becoming Head of Skills, Engagement and Statistics in 2016, her responsibilities include the management of both Springboard+, a national upskilling and reskilling programme and the oversight of national apprenticeships in higher education. In 2019, she implemented the Human Capital Initiative, a €300m investment in Agility and Innovation across the Irish Higher Education System. Vivienne led the establishment of the National Apprenticeship Office for the HEA in 2020. Her role in the HEA involves active strategic engagement with enterprise to strengthen the relationship between higher education promotion and future employment and innovation. 	<p>Tim Conlon, Head of Policy & Strategic Planning, HEA</p> <p><i>Tim leads the policy and strategic planning and system development & performance management units at the HEA. His work is concerned with the strategic performance, development and public accountability of Ireland’s higher education system. Tim graduated from the University of the Creative Arts (UK) and has an MBA from the Smurfit School of Business at UCD. Tim has worked at the HEA for almost twenty years, holding various posts at the national research council, in HEA research and infrastructure, in system development and in policy and planning. Tim has worked on strategic instruments designed to enhance national research output, improve ICT skills provision and to provide for labour market activation. He has carried out research on the nature of relationships between business, enterprise and academia and on research prioritisation. He has led or conducted quality reviews in broad areas from architecture education provision and international quality assurance through to reviews of arts and medical education provision as well as the allocation of degree awarding powers. He worked for the Rt Hon David Willetts MP (now Lord Willetts), the Minister for Universities and Science, from 2007 until the end of 2013, as Chief of Staff and then Special Adviser in the Department for Business, Innovation and Skills. Previously, he was a History teacher and worked at the Association of British Insurers. At the 2010 general election, he was the runner-up in Cambridge.</i></p> <p><i>Nick’s recent research for HEPI includes papers on the sixtieth anniversary of the Robbins Report of 1963, the Graduate Route visa and free speech.</i></p> <p><i>Nick has written for a range of think tanks and journals. His journal articles include pieces on the Coalition’s higher education reforms for the Oxford Review of Education, on access to schools and selective universities for Higher Education Review and on the fifty-year history of student loans for Contemporary British History. Dr Louise Callinan , Head of Access Policy, Higher Education Authority

Louise is Head of Access Policy with the Higher Education Authority (HEA). She has held various roles within the HEA, most recently as Head of Research and Research Policy, and as Director of the Irish Research Council, the national funding agency for research across all disciplines. Prior to this, she was responsible for managing the higher education landscape reform process including the creation of technological universities and for the associated national funding streams.

She also managed the implementation of the System Performance Framework and the annual strategic dialogue process with higher education institutions. Before joining the HEA, she was a lecturer.

Last year, Dylan encountered a setback when he failed a module during the academic year. However, with perseverance and the assistance of resources provided by TUS Second Shot, Dylan passed the module. He believes several supports helped him, but the tutorial support and mock exams offered by the business tutor were especially invaluable in his academic progress.

Looking to the future, Dylan is contemplating various avenues for his future endeavours. His aspirations include the possibility of working abroad, delving into the realm of data analytics through pursuing a master's degree, or transitioning into full-time employment upon completing his studies.



Dr Owen Ross, Head of Transitions & Student Success at the Technological University of the Shannon

Owen is Head of Transitions & Student Success at the Technological University of the Shannon. He completed his PhD in 2023, which focused on evaluating a Student Success Model he developed during his time as Head of Department of Business & Management at the Athlone Institute of Technology. The model comprised three foundation blocks, six student success pillars and twenty-seven actions or interventions. His research found that implementing the model led to a substantial gain in student retention, with the departmental non-progression rate reducing from 36% to 12% over eight academic years.

In April 2023, the TUS Student Education and Experience function launched TUS Second Shot, a multi-annual initiative aimed at increasing student participation and success in the autumn repeat sitting. The initiative adopts a collaborative institutional-wide team-based approach involving multiple stakeholders. TUS Second shot supplements university-wide activities with targeted approaches informed by data. The initial implementation of TUS Second Shot has shown some success at the university level, with notable successful case studies emerging at the departmental level.



Dr Billy Bennett, Vice President for Academic Affairs and Registrar at Atlantic Technological University

Billy is the Vice President for Academic Affairs and Registrar at Atlantic Technological University, having previously held the posts of Vice President for Academic Affairs and Registrar; Head of School of Business; and Head of Teaching and Learning at Letterkenny Institute of Technology (LYIT).

He chairs the Board of Alcohol Forum Ireland and is on the Boards of the Central Applications Office (CAO) and HEAnet. He is a member of the Technological Higher Education (THEA) Apprenticeship Committee; the THEA Internal Audit Steering Group; the QQI Programmes and Awards Oversight Committee; and the National Tertiary Office - Tertiary Partners Network.

The ultimate goal of this line of research is to identify the critical factors that impact university level dropout so that we can better direct preventative resources.
